Re: Invitation to Submit a Letter of Interest in 2018–2019 for a Foundation Relationship Grant.

Dear Friends:

We are inviting letters of interest for the Foundation's 2018-19 Relationship Grant awards.

We appreciate that most tax-exempt organizations are compelled to devote extraordinary energy in pursuit of funding from all available sources, often with little real chance of success. We do not want to *add* to your burdens. Therefore, if you would like to apply for a grant, <u>we presently seek only a brief letter of interest</u>. After reviewing these letters, we will invite a small number of the most promising candidates to submit a more detailed proposal.

Contents of the Letter of Interest.

Before preparing your letter, **please review information** about the Foundation and our Relationship Grant Program on our <u>website</u>.

We will accept letters of interest that are in a PDF format and no longer than two pages total (this *includes* any attachments or exhibits). The letter should succinctly and clearly contain the following information:

- 1. Identification of the organization (to extent that it is not already on the letterhead).
 - a. Organization name.
 - b. Main address, phone number, e-mail and website.
 - c. Contact person (title, address, phone and e-mail if different than main address).
 - d. IRS tax exempt status.

- 2. Please give a brief general description of the geographic, racial and economic population the grant would serve.
- 3. Narrative description of your educational proposal, including:
 - a. How your proposal will address the most important needs and improve innercity education for specific, identifiable individuals?
 - b. How do you know it will work and that your organization is the one to make it work?
 - c. What is the anticipated cost to achieve those results (and how much are you seeking in your grant from the Foundation)?
- 4. If you wish, one or two additional things that you think would be essential for us to consider.

Deadlines and Address

If interested, please submit a letter of your interest in applying for a Brown Rudnick Charitable Foundation Relationship Grant. Only those letters of interest <u>received</u> by Elizabeth McGeoy no later than **4:00 p.m. EDT on Wednesday February 28, 2018** will be considered.
