### 2009- 2010 Grant Programs Get Underway

This year's Brown Rudnick Charitable Foundation Relationship Grants were awarded to correspond with the 2009-10 academic school year. These annual grants seek to improve inner-city education by forming a relationship with a non-profit organization that optimally includes providing financial support, pro bono legal representation and volunteer time. In all, 12 grants were awarded to non-profit organizations in Boston, MA; Providence, RI; Hartford, CT; New York, NY; and Washington, D.C. ### **Hartford's Shelter for Women**

# The Capital Regional Education Council (CREC)'s Truancy Court Prevention Program



The Foundation grant will support this program, in particular, its "Street Smarts to Business Smarts" initiative which will offer these students perspective on the career/business reasons for staying in school.

### Citizens Schools

The autumn after-school coaching of eighth grade students has begun in the Boston office. Through **Citizen's Schools**, five of our first-year associates will coach students from the Edwards School once a week from now until December 8 when all of the effort culminates in a mock trial *WOW*! in the U.S. District Courthouse in front of a real judge and a "celebrity jury".


### **Thompson Island/Outward Bound**

Thompson Island/Outward Bound has been awarded a Foundation grant to support its *Choices* program. ### Providence Plan/Ready2Learn

Ready2Learn, a program of the Providence Plan, works to insure that every child in Providence arrives at school age healthy and ready to learn. The Foundation has provided a Relationship Grant for several years to support AmeriCorps volunteers who work with children, parents and library staff to teach literacy skills. Students make an annual visit to the Providence office to display their skills and Brown Rudnick also provides general counsel services, pro bono, to the Providence Plan. In September, "general counsel" Ed Pare, Foundation Director Brian Gallogly and Foundation Executive Director Al Wallis visited Ready2Learn to meet with staff and AmeriCorps volunteers about the work they will do this year with our grant.

### **Helping Students to Discover Science**

The Foundation awarded a Community Grant to Boston's Excel Academy Charter School in support of a science curriculum for the school's 200 students. Specifically, the grant will be used to purchase a one-year subscription to Discovery Education, which will provide digital learning resources, such as interactive videos and reading material, for the Academy's physics, chemistry, biology, and technology/engineering classrooms.

### **Supporting a Hip Literacy Program in DC**

The Foundation awarded a Community Grant to Washington DC's Perry School Community Services Center, Inc. The grant will support the Perry Center, Inc.'s Home Instruction of Parents of Preschool Youngsters (HIPPY) program, a literacy program which combats poverty through education by teaching the parents of three- to five-year-old preschoolers to read to their children.




"The HIPPY program is a fundamental part of the Center's mission to address chronic poverty and prepare young people so that they will not live in poverty as adults. Over 400 children have graduated from HIPPY with 97% testing at age-appropriate reading levels. This successful program addresses the educational needs of some of Washington's poorest African-American children, and thanks to the Brown Rudnick Charitable Foundation, we will be able to expand the program to more parents."

# Pro Bono is at our **ENTER**

Anti-Defamation League: Through our Center for the Public Interest, during the summer of 2009, Brown Rudnick hosted the Anti-Defamation League's (ADL) closing breakfast in Boston for the ADL Summer Associate Research Project. About a dozen Brown Rudnick summer associates (supervised by Carl Axelrod, Andy Dash, Jeff Friedman, Ed Hershfield & Al Wallis) participated in providing pro bono legal research and advice to the ADL on topics such as:



- May a state deny a law license to an applicant or attorney who participates in activities of or is a member of a known hate group?
- Is the Constitution violated if the state does not provide for an autopsy within time limits for a religious burial?
- Does the National High School Mock Trial Championship violate constitutional rights of students from a religious school if they refuse to adjust the completion schedule to avoid conflict with religious observances?
- Will it violate the constitution if a will requires that beneficiaries to marry a person of a certain religion?
- May a public elementary school teacher keep a Bible displayed on her desk while teaching?

### New Engagements: a sample of recent matters.

**Helping the disabled in Hartford.** We are representing a Hartford tax-exempt organization which assists disabled individuals with occupational training and job placement by providing advice regarding a building lease. *Attorneys: Bob Anthony.*

## "It gets late early out there." Yogi Berra

This has been a strange and challenging year for all and this is true for law firms, and for our Center as well. The autumn edition of our enewsletter (covering activities from July through October) is reaching you a bit later than we had hoped – not because nothing has been going on, but because so much has.

Just two particulars.

One: Given the exceptional needs in our communities, the Brown Rudnick Charitable Foundation determined that despite the wicked economy's erosion of some of our endowment, we would shoulder on and continue to provide essentially the same level of grant support as in the prior year. Couple that with a dramatically increased number of applications for funds and a change in our grant giving year – which now starts in September – and we have found that the turnaround time for getting grants up and running was a little longer than in past years. All good, but just requiring a little additional attention and time.

Another: Almost every major American law firm was forced by the rambunctious economy to defer the usual September start date for new associates, and our firm was no exception. But we continued to keep these future associates "in the family" while also looking for ways through our Center to lessen the impact of the economic downturn on them and on our society. Stipends have been offered to any of these new lawyers who work or volunteer for a public interest legal

organization during their deferral, and the Center has offered help in locating good fit positions.

Presently, these future Brown Rudnick associates are working at or for legal services programs in New York City and New Hampshire, for City Law Departments in Chicago and Boston, for a District Attorneys' offices in New York and Massachusetts, for a state Attorney General's office and for several non-profit organizations providing legal representation on societal issues. All good, but an add on to an already full agenda.

So, our apologies for the delayed arrival of the newsletter this quarter. It got late out there much earlier than we had anticipated.
