Community Preparatory School

Foundation Grant Supports Garden for Special Needs Students in Brooklyn, NY

The Foundation awarded a Community Grant to P396K, a District 75 Special Needs School in Brooklyn, New York. The grant will be used to help the school's Community Outreach Committee purchase supplies to create a garden for the school's special needs, low-income students.

Nicole Jackson, P396K paraprofessional and grant applicant, said, "We believe that the addition of a school garden will promote socialization among the students, and teach them about giving back to the community. More importantly, it will show the students that their disability does not prevent them from being successful community caregivers."

Foundation Grant Brings Coding to the Classroom



The Foundation awarded a Community Grant to P.S. 48 School in Staten Island, New York. The grant will be used for an after-school coding curriculum designed for kindergarten through second-grade students. Specifically, the grant will be used to purchase educational robots that will be used to teach young students how to code.

Jayne Pearlmutter, P.S. 48 STEM teacher and grant applicant, said, "Our school community believes in teaching our students the necessary skills they need to succeed in the future, and developing a coding curriculum is one way we can help them prepare. Thanks to the Brown Rudnick Charitable Foundation, we can teach our youngest students the fundamentals of coding, improving their critical thinking and problem-solving skills."

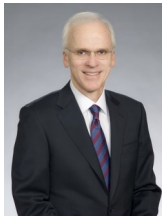

Brown Rudnick Donates Over \$50,000 to Hurricane Recovery Efforts to Support Victims of Hurricanes Harvey, Irma and Maria

Brown Rudnick donated over \$50,000 to assist communities impacted by Hurricanes Harvey, Irma and Maria. Donations were organized through the Firm's Brown Rudnick Center for the Public Interest, the umbrella entity that encompasses Brown Rudnick's pro bono, charitable giving and community involvement efforts.

In September, the Firm donated over \$27,000 to the Texas Access to Justice Foundation's Hurricane Harvey Legal Aid Fund in support of providing legal representation to those impacted by Hurricane Harvey and its aftermath. The Firm donation was augmented by numerous individual contributions from people throughout the Firm.

In October, Brown Rudnick donated nearly \$26,000 to hurricane disaster relief for Puerto Rico, the U.S. Virgin Islands and Florida. This donation was made to the One America Appeal, created by the five living former U.S. Presidents, who have united together to raise money for relief efforts in areas impacted by these storms. The Fund is administered by the George H. W. Bush Presidential Library Foundation.

VLP Honors Brown Rudnick Team with 2017 Denis Maguire Pro Bono Award



Brown Rudnick partner Steven D. Pohl and paralegal Carol Ennis received the 2017 Denis Maguire Pro Bono Award from the Volunteer Lawyers Project (VLP) of the Boston Bar Association. Pohl and Ennis were honored for their work on the “Pro Bono Bankruptcy Project” at the VLP’s 40th Anniversary Celebration, held on September 13, 2017.

VLP had this to say about Steve, Carol and Brown Rudnick, “Since the late 1990s, Pohl and Ennis have provided pro bono legal representation to individuals who are overwhelmed with personal debt and are on the verge of Chapter 7 personal bankruptcy. In 2010, at the request of the judges from the U.S. Bankruptcy Court in Boston, Brown Rudnick, through its Center for the Public Interest, created Brown Rudnick’s Chapter 7 Debt Relief Pro Bono Project, a dedicated program to assist consumers in such circumstances. Working with the VLP, Pohl and Ennis lead the project and members of the firm’s Bankruptcy Group assist individuals in determining whether bankruptcy is an appropriate approach for them, and if so, in preparing court forms and representing them at the meeting of creditors, if needed. Since the program’s inception in 2010, Pohl and Ennis have represented nearly 50 pro bono bankruptcy clients directly, and have been involved in numerous other related cases. Among all participating Boston firms, Brown Rudnick has assumed a leadership position with VLP in taking on debtor relief pro bono cases.

 Pohl regularly represents debtors, trustees, official and ad hoc creditors and equity committees and other interested parties in a variety of in-court and out-of-court situations, including bankruptcy reorganizations, asset sales, loan restructurings, receiverships and assignments for the benefit of creditors. His practice includes all aspects of the bankruptcy process, including contested (and competing) plan confirmation hearings, contested relief from stay and cash collateral hearings, and fraudulent conveyance and preference litigation.”

(VLP) provides free civil legal assistance to low-income residents of Greater Boston, primarily through the pro bono services of private attorneys. VLP makes access to justice possible for people who cannot afford a lawyer.

Brown Rudnick Associate Elliot J. Weingarten Receives Legal Aid Society of D.C. Award for Outstanding Pro Bono Service



Brown Rudnick associate Elliot J. Weingarten received the Making Justice Real Pro Bono Award from the Legal Aid Society of the District of Columbia in recognition of his outstanding pro bono representation and leadership. Beginning in 2013 with his prior firm, and today at Brown Rudnick, through the Brown Rudnick Center for the Public Interest, Weingarten has handled over a half dozen eviction

defense cases and has proven to be one of Legal Aid's most active pro bono volunteers. Weingarten was honored at a Legal Aid of D.C. breakfast reception on September 27, 2017.

"We could not be more proud of Elliot's commitment to providing pro bono representation to low-income people facing the potential loss of their housing," commented Al Wallis, Executive Director of the Brown Rudnick Center for the Public Interest. "And, it is quite an honor to be recognized by the D.C. Legal Aid Society for our providing access to justice to those in need."

Weingarten is an Associate in Brown Rudnick's Litigation and White Collar Defense & Government Investigations group in the Washington DC office. He represents corporations and individuals in SEC and DOJ investigations and related litigation. He has experience handling cases involving FCPA violations, antitrust violations, improper disclosures, accounting practices and policies, and insider trading.

The Legal Aid Society of the District of Columbia is DC's oldest and largest general civil legal services program. In the past year, Legal Aid profiled Weingarten on its Making Justice Real blog and in its 2016 Annual Report.

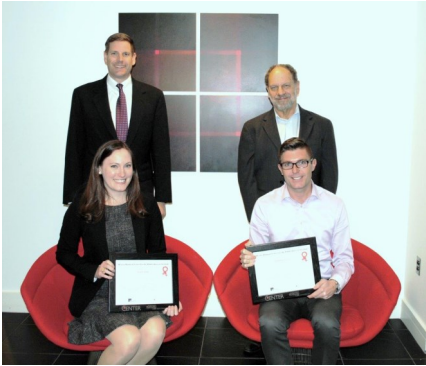
