To extent that it is not already on the letterhead, please include:

- □ Organization name
- □ Main address, phone number, e-mail and website
- □ Contact person (title, address, phone and e-mail if different than main e-mail address)

□ IRS tax exempt status

Project Overview

The Letter of Interest should include a narrative description of your educational proposal. Successful Letters will address the following:

- □ How your proposal will address needs and improve education
- □ Who you are targeting with your proposed project
- □ Why you have selected the proposed project
- □ How you will assess the success of this project
- $\hfill\square$ What is the anticipated total cost to achieve desired results
- □ The grant amount you are seeking from the Foundation

The Letter should also include information related to your organization's diversity, equity, and inclusion (DEI) efforts. Please describe:

- Efforts to promote DEI within your organization
- □ Specific DEI-related goals
- □ How you are tracking progress of your DEI goals

If you wish, you may also include one or two additional things that you think would be essential for us to consider.
